#### 3. Supplementary environmental information

•Complies with the EU RoHS Directive (2011/65/EU) and its amendments including 2015/863/EU. •Manufactured at ISO 14001 certified factories.



### 4. Interpretation

•CO2 emission in Raw material acquisition stage is the largest as 64%. It is important to reduce the size and weight, and to use low environmental impact materials.

•CO2 emission in Use & maintenance stage is the second largest as 18%. It is important to save energy during product usage, to make the life time of consumables(e.g. drum) longer and to reduce amount of toner used when printing. The condition in this CFP evaluation can be different from the one which the user operates under. A choice of the use condition (print mode, print conditions and so on) can reduce the CO2 emission during Use & maintenance stage.

•We evaluated the CFP with Canon's own data of raw materials weight and the general basic unit for the parts because it is difficult to collect the data for a couple of thousands of parts. Accordingly, the results may be different from the specific product specification.

As such, please be advised that this result would be a rough estimate.

## 5. Assumptions of secondary data used

IDEA v2.1.3, and registered data of EcoLeaf Environmental Labeling Program, JLCA data v1.07 are used.

### 6. Remarks
