

4. Interpretation

- CO₂ emission in Raw material acquisition is the largest as 59%. It is important to reduce the size and weight, and to use low environmental impact materials.
- CO₂ emission in End-of-Life is the second largest as 19%. It is important to reduce the size and weight, and improving recycling rates.
- We evaluated the CFP with Canon's own data of raw materials weight and the general basic unit for the parts because it is difficult to collect the data for a couple of thousands of parts. Accordingly, the results may be different from the specific product specification.

As such, please be advised that this result would be a rough estimate.
